### ANTECEDENTES

China's foreign aid programme began in 1950, adhering to the principles of equality, mutual benefit, and non-interference in internal affairs. It aims to support economic and social development in recipient countries and improve livelihoods, with strong emphasis on practical results.

The China Aid Training Program (CATP) plays a key role in strengthening the independent development capacity of partner countries. It promotes international economic and technological cooperation, enhances cultural exchange, and fosters mutual understanding and trust between China and developing countries. Over time, the programme has expanded from technical training to include academic education, official seminars, study visits, and exchange programmes across more than 20 sectors, including agriculture, trade, education, health, and information technology.

Since 2009, CIFAL Shanghai has served as one of the official organizers of CATP, contributing to international capacity development through professional implementation, inclusive engagement, and knowledge exchange. The programme serves as a platform for talent development, international cooperation, and intercultural dialogue.

The successful implementation of CATP at CIFAL Shanghai benefits from the leadership and guidance of:

### 1) Opening and Closing Ceremonies

Structured and formal ceremonies reinforce programme objectives, summarize outcomes, and consolidate cooperation and friendship.

### 2) Thematic Lectures

Courses are carefully designed based on programme themes, partner country needs, and current global priorities.

Methodology includes:

- Expert lectures
- Case-based teaching
- Interactive discussions
- Multi-sector faculty engagement (government, research institutes, enterprises)
- Continuous curriculum updates

The approach prioritizes practical applicability and relevance.

### 3) Company and Institutional Visits

Participants visit:

- Government departments
- Scientific research institutes
- Advanced enterprises

These visits provide direct exposure to China's development practices and sectoral experience, enabling peer learning and dialogue on policy and

innovation.

#### 4) Dialogue and Exchange Sessions

Structured exchanges between Chinese institutions and international participants create platforms for:

- Policy dialogue
- Trade and technology cooperation
- Information and communication technology collaboration
- Bilateral and multilateral networking

#### 5) Cultural Experience Activities

Cultural components are integrated to promote intercultural understanding and mutual respect. Cultural exchange strengthens international friendship and enhances people-to-people connectivity.

The programme promotes inclusive participation and encourages representation from diverse regions and backgrounds. Participation data is collected and monitored to ensure broad geographic representation. Cultural exchange components foster mutual respect and intercultural dialogue.
