ANTECEDENTES

Artificial intelligence is becoming increasingly relevant to international peace and security. Rapid advances in AI capabilities and their broad accessibility create opportunities for development and innovation, but they also increase the risk that powerful tools may be acquired, adapted or misused by actors seeking to cause harm. Of particular concern is the potential use of AI by malicious non-State actors to support cyber operations, disinformation, autonomous or remotely enabled systems, and other activities with destabilizing consequences.

Existing non-proliferation regimes, expert networks and export-control frameworks offer a valuable foundation for addressing some of these risks. However, AI differs from many traditionally controlled technologies: it is largely software-based, develops rapidly, relies on globally distributed infrastructure and expertise, and often has legitimate civilian and commercial applications. These characteristics complicate conventional approaches to controlling access, transfer and end use.

Dedicated dialogue is therefore needed to identify where existing instruments remain useful, where gaps persist, and how future measures can balance security concerns with the benefits of peaceful and responsible AI development. Convened during the First Committee, this side event, organized by UNIDIR and UNITAR, will support a multidisciplinary exchange focused on realistic and implementable policy options.

OBJETIVOS DEL EVENTO

The event aims to:

- Examine the principal proliferation pathways and misuse risks associated with advanced AI technologies, with particular attention to malicious non-State actors.
- Assess the relevance and limitations of existing non-proliferation regimes, export controls, expert networks and related governance mechanisms.
- Identify policy, technical and institutional gaps that require stronger national, regional or international cooperation.
- Generate concrete and implementable recommendations for risk reduction, capacity-building, information-sharing and responsible governance.
- Strengthen dialogue among Member States, the United Nations system, technical experts, research institutions and the private sector.

CONTENIDO Y ESTRUCTURA

The 60-minute event will combine short opening remarks, focused interventions from a multidisciplinary panel, a moderated discussion and questions from the audience. The session will move from problem definition to practical recommendations.

Breakfast will be provided from 8:30 AM-8:45 AM.

METODOLOGÍA

The event will use a moderated, multidisciplinary panel format. Speakers will be invited to provide concise interventions grounded in their respective areas of expertise, enabling the session to integrate diplomatic, policy, legal, security and technical perspectives. The moderator will use a common set of guiding questions to draw connections among the interventions and maintain a clear focus on implementable action.

Audience participation will be incorporated through a dedicated question-and-answer segment. The moderator's closing summary will capture areas of convergence, outstanding policy questions and potential avenues for follow-up. The discussion will be conducted in English.

The event is intended for delegates of the First Committee. Participants attending the First Committee, including those from industry and civil society, are welcome, as are other valid UNHQ badge holders.
