In order to perform efficiently in Geneva's multilateral working environment, it is crucial for diplomats to have a sound knowledge of the structure and functioning

of the UN System and its various Geneva-based components. Over the years, the mandate, governance and decision-making of the UN agencies, funds and specialized agencies based in Geneva have evolved considerably and diplomats are increasingly called upon to cover the work of various organisations with diverse decision-making mechanisms.

This briefing will provide participants with an overview of the United Nations System in Geneva and strengthen their understanding of the mandate and governance of some of the main Geneva-based organisations.

- Define the mandate and functions of some of the major international organisations in Geneva;
- Analyse linkages between the international organisations in Geneva;

The programme includes time for Q&A sessions and discussions. Participants will also be familiarised with privileges and immunities applicable to diplomats accredited to the United Nations Office at Geneva (this presentation will be held in French).
